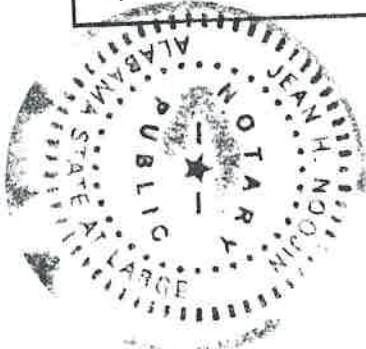

PRA Indemnity provided the initial capital of the Company by advancing \$10 million in exchange for a surplus note issued by the Company to PRA Indemnity. Effective March 31, 2021, affiliate ProAssurance Mid-Continent Underwriters, Inc. was merged with and into affiliate IAO, Inc.

NORCAL Insurance Company completed a reverse stock split and minority shareholder buyout on September 16, 2021 and is now 100% owned by PRA Professional Liability Group, Inc.

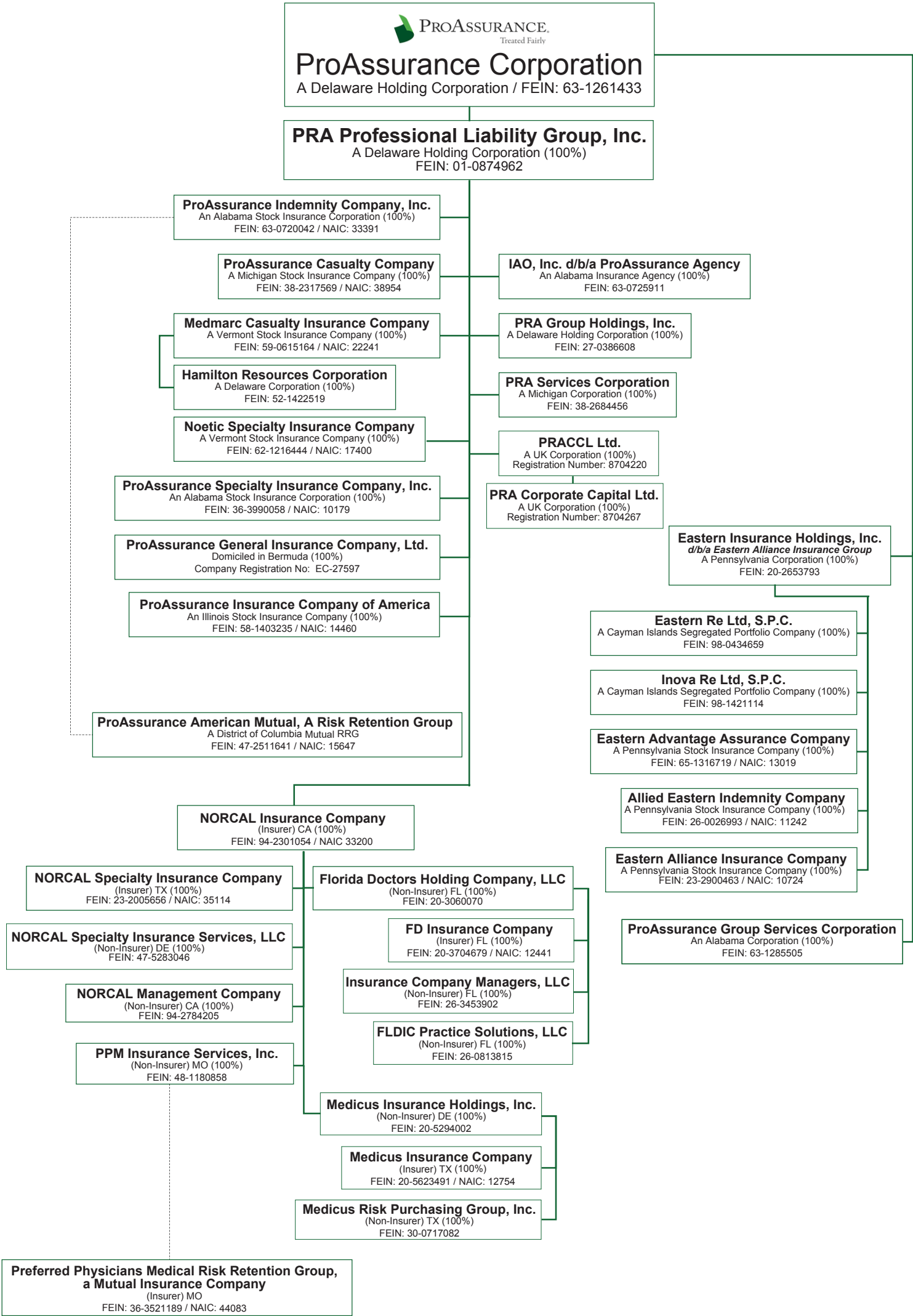
